I understand that I will be disqualified from receiving, and agree to return to Sponsors, any Rewards awarded to me if any statement I make in this Affidavit/Release is false. I agree to return to Sponsors immediately upon demand any Rewards, or the value thereof, which has been awarded to me if any statement I make in this Affidavit/Release is false. I grant to Sponsors, its advertising and promotional agencies, and each of their parent companies, subsidiaries and affiliates, and each of their assigns, designees and licensees, without limitation, the absolute right and permission to use my name, address, likeness, photograph, voice, or biographical information in any and all advertising and Promotional materials, and trade, or to refrain from doing so, in any manner or media whatsoever, worldwide, for advertising and Promotional purposes without notice and without further compensation to me.
